Lights in Darkness

We've all met someone who lights up the room just by walking in. We've also run across a man or woman who seems to cast long shadows wherever they roam. Which person would you rather be

around? Which person would you rather be?

Spiritual maturity is often called enlightenment. This time of year there are many religious and secular festivals that celebrate light. Municipalities and private citizens alike dress their trees will sparkling electric lights. A few brave stalwarts with good fire insurance still put real candles in their windows. We all seek to penetrate darkness with light.

Illuminating light, lightness of spirit, lightness of heart, lightness of being...different sorts of light, all drawing us in like so many moths to a flame. What is it about light that is so appealing?

Bright light, after all, is not a panacea. Under bright lights I look every bit as tired and imperfect as I should be at my ever advancing age. In candlelight I look quite different, perhaps even dewy and lovely. Bright lights can overheat a room, and even burn things that get too close.

Still, given a choice, I'd opt for bright lights. I can always put on a blindfold to sleep or put makeup on my aging face, but without lights I can't see the nuances that make each of us different and unique. I can't see the things in my home or office that need repair. I can't find that which I've lost. I cannot make my way as easily, and I cannot find the things I need for my journey, or repair the equipment that can help me reach my goal.

The same is true for our inner selves. When we are willing to shine the bright light of self-examination on our characters it can be frightening, especially at first. What if I learn I am angry or slothful or envious? A better question is, "What if I am angry or slothful or envious and I don't know that I am?"

As the days grow shorter and darker, allow yourself to be reminded to shed light on the things about yourself you'd With the presidential election over, defense officials are expected to announce soon military retirees and their dependents living more than 40 miles from a military treatment facility or base closure site will lose access to TRICARE Prime, the military's managed care option. These beneficiaries

would be expected to shift to TRICARE Standard, their fee-for-service insurance option, which would mean an increase in out-of-pocket costs for beneficiaries who are frequent users of health services. A total of 171,000 retirees and dependents are expected to have to shift coverage when remote Prime networks go away. Tentative plans are for this to occur 1 APR in the West Region, which would coincide with United Health Military and Veterans Services taking over the region's support contract from TriWest Healthcare Alliance after 16 years. The North and South TRICARE regions are expected to close down Prime service areas beyond 40-mile catchment areas of bases or base closure sites by Oct. 1, 2013, the date when current Prime enrollment periods expire for most beneficiaries. Lawmakers hear the clock ticking toward deep defense and domestic spending cuts, and senior members of both parties appear poised to pass a measure during a lame duck session that would add additional time to that clock. Senior congressional Democrats and Republicans are talking openly about kicking down the road the date that would trigger separate \$500 billion, 10-year cuts to planned defense and domestic spending. Senate Budget Committee member Mark Warner (D-VA) said on 8 Nov lawmakers hope to "make a down payment" during a coming session-ending lame duck period "to avoid sequestration." He was referring to a budgeting tactic to reduce nonexempt defense and domestic accounts on 2 Jan short of a \$1.2 trillion debt-paring bill or a measure extending the sequester countdown clock. House Speaker John Boehner (R-OH) also continues talking about the need to delay those cuts, which economists say - when

ANNOUNCEMENT! Greetings to all our NWFMOA colleagues, friends, and family members! Since the first of September, I have been diagnosed with shingles. Although conventional wisdom states the symptoms will persist with pain, itching, and skin discoloration for some 2-3 weeks, mine have been with me now for well over two months with no indication of a near-term departure. So, the purpose of this message is to advise those of you who have had the chicken pox to get the shingles vaccine and save yourself a good deal of physical agony and lost time, such as having to cancel my classes at UWF for the first time in 10 years! We have been told at the clinics at Eglin and Hurlburt that all you need to do to get your vaccine is 1) to be 50 or over, 2) show up with your ID card, and 3) get the vaccine without further adieu. Also, it has been recently announced that if you cannot remember whether you had chicken pox, it is recommended that you receive the vaccine anyway.

coupled with expiring tax cuts — could send the U.S. economy into a new recession. "Lame duck Congresses aren't known for doing big things and probably shouldn't do big things, so I think the best you can hope for is a bridge," Boehner told CNN on 4 Nov.

Lawmakers during the lame duck period would have just a few weeks to pass a deficit-cutting bill that would have to cover defense spending, tax reform, domestic entitlement program reform, and a score of other prickly complex issues. Rep. Allyson Schwartz (D-PA), House Budget Committee vice ranking member, also has recently called for a short-term delay. Speaking at a forum in Washington on 16 Oct, Schwartz said it would be "very tough" for Congress to pull off such Herculean work in just six weeks. She called on lawmakers to try to pass a smaller legislative package that deals with "the things we agree on," such as extending middle class tax cuts enacted during the George W. Bush administration and establishing a sustainable growth rate for the Medicare program.

Auxiliary Corner

Surviving military spouses and children might be eligible to receive educational benefits. One program, open to military spouses and children, is the Department of Education Survivors and Dependents Assistance, or Chapter 35, program, which is highlighted below. A second program, open only to children of fallen service members, is the Marine Gunnery Sergeant John David Fry Scholarship, which will be highlighted in the December issue of The Affiliate. These are very different programs with very different benefits. The Marine Gunnery Sergeant John David Fry Scholarship is much more comprehensive than the Chapter 35 program and is available for the surviving children of post-Sept. 11, 2001, active duty deaths. Eligible surviving military spouses and children of pre-Sept. 11, 2001, active duty or service-connected deaths are eligible for Chapter 35 benefits.

Chapter 35 provides education and training opportunities to eligible dependents of certain veterans who were killed or died on active duty or who died of service-connected illnesses or injuries. This benefit is available to spouses and the dependent children of those veterans at the time of the servicemembers' deaths who are listed on the Report of Casualty (DD Form 1300). It offers up to 45 months of education to be used for degree or certificate programs, apprenticeships, or on-the-job training. Spouses also may take correspondence courses. Surviving military children must be between the ages of 18 and 26 to take advantage of this program. The benefits are offered for up to 10 years for most survivors whose spouses died prior to Oct. 10, 2008. Benefits for military spouses end 10 years from the date the VA finds them eligible or from the date of death of their servicemember spouses.

However, effective Oct. 10, 2008, if the VA rated a veteran permanently and totally disabled, with an effective date of three years from discharge, his or her spouse will remain eligible for 20 years from the effective date of the rating.

No benefits may be paid for any training taken prior to that date. For spouses of service members who died on active duty, benefits end 20 years from the date of death.

The maximum benefit under Chapter 35 is \$987 a month. This benefit is paid for the time the student is actually in school, not by the semester. Holidays and breaks are not paid for, so the payment varies by month.
