Development and Leadership and an experienced peer evaluator with the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC) and the Higher Learning Commission. In December 2016, Dr. Stephenson was elected to the SACSCOC Board of Trustees. Most recently, he was selected to the Board of Directors for the Florida Association of Colleges and Universities and the Steering Committee for the Florida College System Council of Presidents.

He earned an associate degree in science from Walker Junior College, followed by a Bachelor of Arts degree in business administration from Birmingham-

Recently returned from Orlando while attending the Florida Council's Winter Leadership Forum. In addition to staying warm, I, as always, learned a lot. It'd take several pages to relate all the important points so I'll have to hit the highlights, perhaps in more than one column, as I did in a lengthy email to my fellow NW Florida chapter presidents who didn't attend.

There was the usual foot-stomping about administrative trivia. Thank God we (or more selfishly, I) have George Colton and Fred Westfall, our treasurer and secretary, to ensure these seemingly minor but in fact really important details are completed. No one is more grateful for their contributions than I am!

The (relatively) new MOAA president, Lt Gen Dana Atkins, spoke on several occasions and communicated tons of good information.

- 1. MOAA convention will be 1-2 November in Phoenix.
- 2. MOAA will soon offer pet insurance through its insurance affiliate, Mercer. (Don't laugh. They've determined there's a viable/profitable need).
- 3. Talked at length about his success in recruiting. He's got a number of sound bites about how MOAA has protected benefits or added to some for all military members. For example, MOAA's success in lobbying against the COLA cut means an extra \$100K to a

To a lesser degree, the same applies at the chapter level. While our recruiting has increased significantly over the past several years, we still don't have a focused and organized effort. Nick Marotta has taken the stick to change that.

- Gave figures about MOAA financial reserves and how we've greatly improved in 3 years. Discussed revenue streams. Slightly scratched my bean-counter itch.....
- 5. Despite an approved NDAA, we're still \$55B short due to sequestration. He isn't optimistic that it'll be repealed due to polarization in Congress. He briefly detailed MOAA's revenue streams and reserve balances. Some staffers have even voiced that the elimination of "earmarks" has taken away their ability to get things done—an interesting perspective and comment on the lack of congressional movement on virtually anything.

The state convention will be at Sanibel Harbor this year. The dates are Jun 1-3 2018. The flyer and application form are both available on the council's website, moaafl.org, under the Events tab. Now I realize this event hasn't generated a lot of participation in the past probably because there's "nothing in it for me." This year promises to change that. Here's why:

The room rate is only \$139 and is tax free with no parking/resort fees. That's a HUGE discount. For this location, nightly rates normally start at \$250. Our rate is guaranteed for 3 days prior and after the convention. Many registrants are taking advantage of that for an extended stay. There is a great harbor cruise with seating limited to 120 and 40 have already signed up. A council officer has "ops checked" it and raves about it so get your reservation in early to guarantee a cruise seat. Janet and I have always limited our stays to the days of the conventions but in this case we going to take advantage of the great rates. And after all, we're retired. Why not take time to stop and smell the roses (orchids)?

The chapter Levels of Excellence Award submissions are coming up quickly. MOAA has upgraded its on-line tool to check membership status. The bad news is that they now have great visibility of which chapter members are NOT national members. That creates the very real possibility of killing our chances for another five star award because so many points are awarded for the percentage of chapter members who also belong to MOAA. ## Surviving Spouse Corner

### A Year in Review

The Surviving Spouse Advisory Committee (SSAC) began 2017 with the exciting opportunity to develop the second MOAA Virtual Chapter — following in the successful footsteps of the Uniformed Services Nurse Advocates Virtual Chapter. We completed the necessary paperwork in August and forwarded it to MOAA to be submitted to the board of directors for their approval at their February meeting.

In April, SSAC members participated in MOAA's annual Storming the Hill event in Washington, D.C., during which we asked legislators to prevent disproportional TRICARE fee hikes, end harmful sequestration cuts, and eliminate the Survivor Benefit Plan/Dependency and Indemnity Compensation offset affecting 63,000 surviving military spouses or extend and increase the Special Survivor Indemnity Allowance (SSIA) if the offset cannot be eliminated. We received positive feedback, and Congress included a provision in the FY 2018 National Defense Authorization Act that provides a permanent extension to the SSIA. We will continue to push Congress to eliminate the offset in its entirety.

We continued efforts to increase our visibility within the MOAA membership, including presentations about the SSAC at the Regional Leaders Workshop in Memphis in September and in Oklahoma City in November and

### MOAA'S 2018 Goals and Florida **Legislative Session**

We have started a new year, and with it comes a new set of goals and priorities from MOAA's Government Relations team. I call your attention to the January 2018 issue of the Military Officer magazine from MOAA and the article on pages 36 thru 40 in the article titled "Top 10 Goals for 2018". This year's priorities include TRICARE, military pay and quality of life benefits, military retirement and COLAs, wounded warrior programs, benefits for survivors and disabled, Guard and Reserve requirements, family support programs, and access to VA health care. This article is worth your time to read if you have not already done so.

The Florida Legislature began its 60-day session for 2018 on January 9th. My quick review of Bills filed in the House and Senate on January 9th showed several that can have positive impacts on military and veterans. Some of these are: SB (Senate Bill) 328 and HB (House Bill) 107 which will require the Dept of Safety & Motor Vehicles to create a veterans' ID card for honorably discharged veterans; SB460 and HB75 would waive certain student activity and service fees for active duty military attending college courses using military tuition assistance; SB816 and HB69 create a sales tax holiday for veterans of US Armed Forces on certain items from Nov. 1 thru Dec. 31 annually; and, SB910 and HB603 would create exemptions for business taxes for veterans and surviving spouses. In addition, Senate Resolution 550 and House Resolution 319 support a moratorium on drilling in the Gulf of Mexico east of the Military Mission Line.

Filing a Bill is one thing; to get it passed requires approval by three separate committees in each of the Senate and House followed by approval by the Senate and House as a whole. A lot can happen during the legislative process to amend or derail proposed bills. I will follow-up on the above proposed legislative bills with impact on our military and veteran citizens in future issues of the Defender.

## Scholarship Fund

### Scholarship Fund Board Increases JROTC Scholarships

On January 11th, the Board of Directors of your Scholarship Fund held its annual meeting which resulted in many changes to our Scholarship Programs for 2018. Firstly, we have increased the number of scholarships for JROTC cadets from five to seven by adding one scholarship each for JROTC cadets at Navarre High School and Walton High School in addition to the five high schools in Okaloosa County. Secondly, we increased the value of the scholarships from \$1,500 to **\$2,000 each**. These values are more comparable to what other nonprofit organizations are awarding for their scholarships. One of these new \$2,000 scholarships will be the "Chong Cha (Kim) Parisot Memorial Scholarship" and will be fully funded by Dave Parisot in memory of his wife of 35 years. Thirdly, the Scholarship Fund Board assigned the amount of \$4,000 to the "Lt Col James (Jim) Heavener Memorial Scholarship" (see Jan. 2018 Defender) which will be competed for by the winners of the seven individual high school scholarships and will replace the previous \$3,000 scholarship. Thus, in 2018, we plan to award a total of \$16,000 in college scholarships to local JROTC cadets. All of the above changes were adopted unanimously by your seven Directors.

These increases in our scholarship amounts would not have been possible without the generous donations to the **BG Frank Glunn Century Club** and the **Gold Century Club** by our NWFMOA Chapter members, by our business donors and sponsors, and the various fundraisers we hold. Your Scholarship Fund Board <u>thanks</u> <u>each of you</u> who have helped to improve our financial standing. Since 2015, our Century Club memberships have increased from 18 members to 34 members. Are you ready to add your name to the donor list?

At the Scholarship Board meeting, the Directors also approved a "**Certificate of Membership in the Gold Century Club**" to be given to each person who has donated \$500 (or more) to the Scholarship Fund (cumulative since 2015). We will start distributing these certificates at the February 1st Chapter luncheon.

**<u>NEW EVENT</u>**: On Saturday, February 10<sup>th</sup>, from 3:00 to 5:00PM, the Scholarship Committee will host a **Wine Tasting and Buffet** at *The Twisted Grape* in Shalimar.
