### Opus One Decks the Halls with Music

#### **Educational Benefits - Part II**

Surviving military spouses and children might be eligible for educational benefits. One program, the Department of Education Survivors and Dependents Assistance, or Chapter 35 program, was covered in the November issue of *The Affiliate*. A second program, the Marine Gunnery Sergeant John David Fry Scholarship, is highlighted below.

The Fry scholarship, part of the Post-9/11 GI Bill, entitles surviving children of active duty servicemembers who died in the line of duty on or after Sept. 11, 2001, to use the Post-9/11 GI Bill benefit. Eligible children are entitled to 36 months of benefit at the 100-percent level. They have 15 years to use the benefit beginning on their 18th birthdays and may use it until they turn 33. A law effective Aug. 1, 2009, simplifies the tuition and fee rates for those attending public schools and creates a national maximum for those enrolled in private or foreign schools.

Tuition, fees, housing, and book allowances are covered for public schools. Private and foreign school costs are capped at \$17,500 annually. Break or interval pay is not payable under VA education benefit programs unless there is an executive order of the president or an emergency.

The Post-9/11 GI Bill also is available to the spouse or child of an eligible active duty or retired servicemember who has not used his or her GI bill benefit and who wishes to transfer it. If the veteran dies before using his or her benefit, it does not transfer to the surviving spouse or child. The servicemember must exercise his or her transfer eligibility before separating or retiring from the service. MOAA recommends servicemembers do so as early in the careers as possible so obligated service can be completed. (For more information, <u>visit www.gibill.va.gov</u>.)

MOAA also offers scholarship opportunities to military children through the MOAA Scholarship Fund, which provides grants and interest-free loans for undergraduate college educations. ### TRICARE/Walgreens Update

Express Scripts has determined it will maintain the same robust retail pharmacy network of more than 57,000 pharmacies available to TRICARE beneficiaries. Walgreens left the TRICARE retail pharmacy network when their contract with Express Scripts expired on December 31, 2011. On July 19, 2012, Express Scripts and Walgreens announced a new network agreement for Walgreens participation in one of Express Scripts networks. However, in line with TRICARE Management Activity's commitment to the efficient management of the TRICARE Pharmacy benefit, Walgreens will remain designated as a non-network pharmacy provider for TRICARE beneficiaries. You will be able to purchase the drugs at Walgreens, but you will have to send the bills to TRICARE for reimbursement. (Source: TRICARE website)
