# Legislative Musings...by Bill Van Hoesen

Are you ready for a "What the H#\$&" shake of the head? The federal debt limit will have no force or effect until May 19 thanks to Senate action to clear a House-passed measure for President Obama's signature. In addition to suspending the debt limit, the bill commits the Senate (and the House) to passing a budget resolution for the first time in four years under

pain of its members having their paychecks withheld. (If you think this will happen, I understand the Verrazano Bridge is for sale) Before the bill could pass, Democrats had to table several Republican amendments from Rob Portman of Ohio, Pat Toomey of Pennsylvania, Rand Paul of Kentucky, and David Vitter of Louisiana. Portman offered two amendments: the first would require any bill to raise the debt limit include non-interest spending cuts of an equal or greater amount; the second would cut discretionary spending by one percent every three or four months if Congress does not agree to a budget resolution by October 1, 2013. Toomey's amendment would prioritize certain accounts for receipt of payment in the event Congress did not raise the debt limit, placing debt interest, Social Security, and military personnel at the front of the line. The Paul amendment would have banned the transfer of certain weapons systems such F-16 fighter jets to Egypt. The Vitter amendment would have introduced spending cuts to the bill. All but the Paul amendment, which had very little support, split the Senate exactly along party lines. Democrats rejected each amendment unanimously except the second Portman amendment, which attracted the support of Kay Hagan (N.C.), Claire McCaskill (Mo.) and Jon Tester (Mont.).

Now how about a good laugh? House Bill # H.R. 444 -- The Require Presidential Leadership and No Deficit Act or Require a PLAN Act - Directs the President, if his budget for FY2014, as submitted to Congress, results in a projected deficit in every fiscal year for which estimates are provided, to submit by April 1, 2013, a supplemental unified budget that includes: the information required by law for the President's budget, an estimate of the earliest fiscal year in which the supplemental budget is not projected to result in a deficit, a detailed description of additional policies to be implemented in order to achieve such result, and an explanation of the differences between the President's original FY2014 budget and the supplemental unified budget. I understand this has about as much chance of being approved as does a snowball in hell.

# **Auxiliary Corner**

The loss of a spouse, regardless of whether the death is sudden or the result of a long illness, is very traumatic for the surviving spouse. We are never emotionally prepared for the loss of a spouse, which creates a major life change. Among these changes are financial hardship, loss of role as a spouse or caregiver, loneliness, living single in a couple's world, the loss of couple friends, and all the paperwork, which can be overwhelming. Yet, there is much we can do now to become aware and prepare for at least some of these changes in our lives.

It's very important to be aware of the location of wills, durable powers of attorney, living wills, insurance documents, safety deposit boxes and keys, checking and savings accounts, investments, and passwords to online accounts. We encourage setting aside, in a separate bank account, at least six months worth of living expenses for the surviving spouse to use until financial matters are settled.

When a military retiree or an active duty service member dies, retired pay stops on the day of death. The surviving spouse and children might be entitled to many survivor benefits — medical insurance; pay; military ID cards with moral, welfare, and recreation privileges such as commissary and exchange; and other military privileges.

The Survivor Benefit Plan (SBP) might be payable by DoD up to 55 percent of retired pay, depending on the level of the retiree's participation upon retirement. Also, if the retiree dies of a service-connected illness or injury, the surviving spouse might be eligible for Dependency and Indemnity Compensation (DIC), payable by the VA. Under current law, SBP is reduced dollar for dollar up to the total value of DIC. If the death occurs on active duty post-9/11, the service member is considered retired with 30 years of service at his or her current rank or rate. The surviving spouse will receive the survivor benefit on that basis, plus DIC as an offset. The spouse has the option to transfer this SBP benefit to a child and to receive DIC only, forfeiting SBP forever. In this case, SBP will end when the child reaches majority, at age 18, or 22 if a fulltime student. Remarriage affects both SBP and DIC, so be sure to check with each program before you proceed to the altar.

Surviving spouses age 60 or older also may collect deceased spouses' Social Security benefits. Younger survivors with children under age 16 also may collect these benefits if the survivors have worked enough quarters to be eligible. A child will receive the benefits until age 18.


