Another Welcome Visit from our State Senator

For our program on May 5th, we will enjoy a return visit from State Senator Don Gaetz. Senator Gaetz has appeared before our chapter in the past, but it's always nice to have a chance to visit with him again.

Former Florida Senate President Don Gaetz began his career in the private sector where he spent more than 30 years working to improve access to quality health care services. He is the retired co-founder of VITAS Healthcare Corporation, which provides innovative hospice care, working with patients and families to offer comfort and preserve dignity in the face of terminal illness. He also served as President of the National Hospice Organization.

While working in the private sector, President Gaetz became concerned with the quality of education his children were receiving in the local public school system. He joined the PTA and was later elected to the school board before

becoming the first non-educator ever elected Superintendent of the Okaloosa County School District. Under his leadership, Okaloosa Schools became the highest performing public schools in Florida and won numerous national awards for academic excellence.

In 2006, President Gaetz became the first non-legislator in more than 50 years to be elected to the Florida Senate with no opposition. In November 2012, he was unanimously elected by his Senate colleagues to serve as President of the Florida Senate.

Senator Gaetz earned undergraduate degrees in religion and political science and a master's

degree in public administration. Senator Gaetz and his wife, Victoria, have been married for over 30 years. The Gaetz's reside in Niceville where they are members of St. Paul's Lutheran Church. Their daughter, Erin, is a producer in New York and their son, Matt, is a State Representative for District 4 in Northwest Florida.

Latest VA Accountability Failures

Nearly every day we are reminded that accountability at the Department of Veterans Affairs is almost non-existent. VA's announcement last week that no one will be seriously disciplined for wasting more than \$1 billion on a failed construction project and that a few executives might receive a weak slap on the wrist or a temporary written warning for a relocation scandal that cost taxpayers more than \$400,000 is more proof of this sad fact. One thing is clear: this dysfunctional status quo will never change until we eliminate arcane civil service rules that put the job security of VA bureaucrats ahead of the veterans they are charged with serving. The House acted to do just that last summer with passage of the VA Accountability Act, which would give the VA secretary the authority to swiftly fire or demote any VA employee for poor performance or misconduct while protecting whistleblowers and limiting the agency's ability to place misbehaving employees on paid leave. If the Senate doesn't follow suit with similar legislation to do the same thing, it is illogical to think VA's many problems will ever be fixed.

Memorial Day Monday, 30 May 2016

Memorial Day, an American holiday observed on the last Monday of May, honors men and women who died while serving in the U.S. military. Originally known as Decoration Day, it originated in the years following the Civil War and became an official federal holiday in 1971. Many Americans observe Memorial Day by visiting cemeteries or memorials, holding family gatherings and participating in parades. Unofficially, at least, it marks the beginning of summer.

Early Observances of Memorial Day

The Civil War claimed more lives than any conflict in U.S. history, requiring the establishment of the country's first national cemeteries. By the late 1860s Americans in various towns and cities had begun holding springtime tributes to these countless fallen soldiers, decorating their graves with flowers and reciting prayers.

It is unclear where exactly this tradition originated; numerous different communities may have independently initiated the memorial gatherings. Nevertheless, in 1966 the federal government declared Waterloo, New York, the official birthplace of Memorial Day. Waterloo—which had first celebrated the day on May 5, 1866—was chosen because it hosted an annual, community-wide event, during which businesses closed and residents decorated the graves of soldiers with flowers and flags.

Decoration Day

On May 5, 1862, General John A. Logan, leader of an organization for Northern Civil War veterans, called for a nationwide day of remembrance later that month. "The 30th of May, 1868, is designated for the purpose of strewing with flowers, or otherwise decorating the graves of comrades who died in defense of their country during the late rebellion, and whose bodies now lie in almost every city, village and hamlet churchyard in the land," he proclaimed. The date of Decoration Day, as he called it, was chosen because it wasn't the anniversary of any particular battle.

On the first Decoration Day, General James Garfield made a speech at Arlington National Cemetery, and 5,000 participants decorated the graves of the 20,000 Union and Confederate soldiers buried there. Many Northern states held similar commemorative events and reprised the

Surviving Spouse Corner

The Special Survivor Indemnity Allowance (SSIA) was established in October 2008 as a first step toward eliminating the Survivor Benefit Plan/Dependency and Indemnity Compensation (SBP/DIC) offset. SBP is an annuity purchased upon retirement to ensure the spouse will continue to receive income (up to 55 percent of the retiree's elected amount of coverage) in the event the retiree pre-deceases his or her spouse. SBP also is awarded automatically to:

- surviving spouses of retirement-eligible servicemembers (i.e. with 20-plus years of service) who died on active duty before Sept. 11, 2001; and
- surviving spouses of all servicemembers (regardless of length of service) who died on active duty after Sept. 11, 2001.

If the servicemember's death was caused by a service-connected illness, then the surviving spouse also is eligible for DIC from the VA in the amount of \$1,254 per month. DIC is deducted from SBP dollar-for-dollar, up to the full amount of SBP. Congress agreed this offset was wrong but was unable to come up with the funding to fully eliminate the offset. They instead created SSIA. It was a 10-year allowance, which started at \$50 a month, is currently \$275 a month, and will increase to \$310 by 2017. The problem is current statutory authority to pay SSIA is set to expire Oct. 1, 2017.

It is important for SSIA to be extended and increased in this year's (would it be this year's or the 2017) Defense Authorization Bill if the funds to eliminate the SBP/DIC offset are not found. Otherwise, 63,000 surviving spouses affected by the SBP/DIC offset will see a \$3,720 reduction in compensation in 2017.

Two bills, H.R. 4519 and H.R. 4493, were introduced by Rep. Alan Grayson (D-Fla.) in the House of Representatives to increase and extend SSIA as follows:

- H.R. 4519 would increase SSIA over five years: \$400 in 2018; \$475 in 2019; \$600 in 2020; \$700 in 2021; and \$800 in 2022.
- H.R. 4493 would increase SSIA to \$400 a month for one year in 2018. This bill is a backup bill to H.R. 4519 in case funding for the five-year bill cannot be found. SSIA then would end in 2019 and again have to be addressed if the offset was not eliminated.

If monies to eliminate the SBP/DIC offset cannot be found, it is imperative SSIA not only be extended but also increased. Pursuing SSIA increases does not remove the goal to eliminate the SBP/DIC offset completely. SSIA's principal purpose is twofold: 1) to provide at least partial, immediate reimbursement to SBP/DIC survivors until full repeal of the offset can be achieved, and 2) provide an additional option to attain repeal of the offset through a phased-in approach, with steady increases to the annual SSIA amounts.

Please support the elimination of the SBP/DIC offset by asking your congressional representatives to cosponsor H.R. 1594 in the House and S. 979 in the Senate. Also, seek support for H.R. 4519. Use the toll-free Capitol Hill line (866) 272-MOAA (6622) to call your congressional representatives today.

tradition in subsequent years; by 1890 each one had made Decoration Day an official state holiday. Many Southern states, on the other hand, continued to honor their dead on separate days until after World War I.

Evolution of Memorial Day

Memorial Day, as Decoration Day gradually came to be known, originally honored only those lost while fighting in the Civil War. But during World War I the United States found itself embroiled in another major conflict, and the holiday evolved to commemorate American military personnel who died in all wars.

For decades, Memorial Day continued to be observed on May 30, the date Logan had selected for the first Decoration Day. But in 1968 Congress passed the Uniform Monday Holiday Act, which established Memorial Day as the last Monday in May in order to create a three-day weekend for federal employees; the change went into effect in 1971. The same law also declared Memorial Day a federal holiday.

Memorial Day Traditions

Cities and towns across the United States host Memorial Day parades each year, often incorporating military personnel and members of veterans’ organizations. Some of the largest parades take place in Chicago, New York and Washington, D.C. Americans also observe Memorial Day by visiting cemeteries and memorials. On a less somber note, many people throw parties and barbecues on the holiday, perhaps because it unofficially marks the beginning of summer.

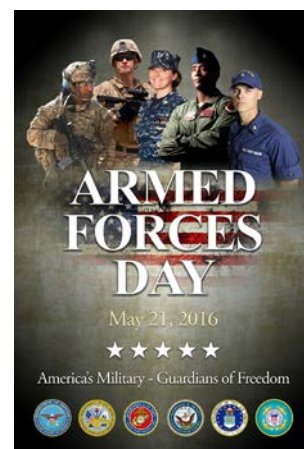
