Junior Reserve Officer Training Corps

For our program this month, we will be joined by LTC Michael R. Ramirez. He will discuss programs, objectives, and enrollments of the five high school JROTC programs in our area. **The Junior Reserve Officer Training Corps (JROTC)** is a federal program sponsored by the United States Armed Forces in high schools and also in some middle schools across the United States and United States military bases across the world.

LTC Michael R. Ramierz, USA (Ret), enlisted in the Reserves in Pensacola, FL in 1986 as a Multi-Channel Telecommunications Equipment Operator. Upon completion of Basic Combat Training and Advanced Individual Training, he returned to Pensacola and the University of West Florida and served in the Simultaneous Membership Program while earning a commission through ROTC and was a Distinguished Military Graduate.

After commissioning from the University of West Florida in 1988, LTC Ramirez's first assignment was as an Assistant Chief of Staff, Operations (S3) in the 1st Squadron, 1st Cavalry, the division cavalry squadron for 1st Armored Division in Ansbach, GE. In that capacity, he deployed in 1990 to serve in DESERT STORM—his first of three combat tours. Prior to redeployment he became a platoon

leader with B Troop. In 1991, he returned to the United States and served as the Headquarters Company XO

and later, as a chemical intelligence officer for the Chemical Center at Aberdeen Proving Grounds, MD. After completing the Advanced Course, he was assigned to 1st Cavalry Division, Ft. Hood, TX, where he served as Assistant Chief of Staff, Intelligence (S2) in 1-12 Cavalry Battalion and the Deputy Chief of the Analysis and Control Element.

Following this, he then commanded A Company, 312th MI Battalion. After company command, LTC Ramirez deployed with 1st Cav to serve a year

This change will require a change to our Bylaws. Voting on these changes will be at our May membership meeting.

The proposed changes to our Bylaws are summarized below.

ARTICLE IV MEMBERSHIP

Section 1. Classes of Membership

- (a) VOTING MEMBERS.
- (b) AUXILIARY MEMBERS.
- (c) HONORARY MEMBERS.
- (d) ASSOCIATE MEMBERS. Those individuals who are not eligible for Voting Membership or Auxiliary Membership, but who have an interest in supporting and participating in NWFMOA programs and functions. Examples would be our business partners and non-member donors to the Scholarship Fund, chamber of Commerce/Military Affairs executives, business leaders/executives, etc. Associate Members are non-voting and by invitation and approval of the NWFMOA Board of directors. Dues shall be the same as for Voting Members in ARTICLE VII, Section 4. Dues.

ARTICLE VII COMMITTEES, MEETINGS, DUES

Section 4. Dues

- (a) The annual dues for members
- (b) A Member will be dropped from membership for nonpayment of dues if their dues remain unpaid for a period of 90 days after January 1 of each year. A member who has been dropped for nonpayment of dues or special

The age of the computer and smartphone has changed the way people communicate and interact with one another. According to an article from Pew Research Center, around 7 in 10 Americans use social media to “connect with one another, engage with news content, share information, and entertain themselves.” And it is commonplace to see individuals walking down the street, sitting at a table, or, unfortunately, driving their cars while using a cell phone.

Social media even gained added emphasis during this past election as a tool for candidates to connect directly with the American people. Some of the more common social media applications include:

Facebook — a social networking site that allows you to connect with friends, family, and peers; share messages, videos, and photos; and like and follow companies, causes, business, etcetera.

Twitter — a social networking site that enables users to send and receive communication in 140 characters or less.

LinkedIn — popular for professionals looking to network, connect with peers, and job search.

Instagram — used to take, edit, share, and view photos and videos.

Snapchat — similar to Instagram in that it’s photo and video focused, but the messages are available for only a short time.

Pinterest — used to create a personal catalog of websites, pictures, ideas, and how-to’s for later use.

of peacekeeping duty in Bosnia-Herzegovina where he ran the counterintelligence/human intelligence teams for the division. Upon redeployment, he was assigned to the Tank, Automotive, and Armaments Command, Warren, MI, where he served as the Assistant DCS for Intelligence (G2). Following Command and General Staff College, LTC Ramirez was assigned to the 3rd Infantry Division (3ID) at Ft. Stewart, GA, in 2002. He was temporarily assigned to Intelligence and Security Command where he served on an Information Operations field team. That temporary duty was curtailed after six months so that he could return to 3ID to deploy with the division to Kuwait as the G2 Operations Officer.


LTC Ramirez was part of the initial assault on Baghdad in March 2003. On that tour in Iraq, he became the S2 for 1st Brigade/3ID. After redeployment, he became the Executive Officer (XO) for the 3rd Special Troops Battalion—a newly created divisional battalion—where he coined the unit motto, “Forged Through Sacrifice.” As the XO, he deployed with the battalion to Iraq in 2005. Upon redeployment, LTC Ramirez became the S3 for the 513th Military Intelligence Brigade, Ft. Gordon, GA, where he served for two years. He retired in November, 2008.

LTC Ramirez resides in Pensacola with his wife, Kim. His son, Michael, received an undergraduate degree from, and is working on, his Master’s degree at Auburn University. His daughter, Christa, graduated from Florida State University. He serves as the Senior Army JROTC Instructor at Baker High School, Baker, FL.

Since then, I have learned that we actually have seven (**Lt Col Lewis “Rocky” Heckroth** was not listed) along with a fourth WWII widow [**Ginny Mills** (Major Rodney Mills)]. My apologies for this oversight.

Of our seven WWII veterans, five were able to attend the World War II banquet as our guests on April 7th at the Emerald Coast convention Center. (See the caption under the photo for our Chapter attendees). What a night! To see over 50 local WWII veterans in one room was quite a sight. There were a couple in wheelchairs and a few using a cane, but the majority seemed very spry, elegant, and wore their age well. A great program was put on by the Greater Fort Walton Beach Chamber and the Eglin Federal Credit Union. Interviews with **Lt Col Dick Cole** (age 101), the sole surviving Doolittle Raider, and two Pearl Harbor survivors, along with a talk by **Lt Gen Leroy Manor, Jr.**, were the highlights of the program. There were about 500 people in attendance to honor these veterans.
