Helping To Build Future Military Officers And Leaders

The title of this article is the motto of your **NWFMOA Scholarship Fund**. We do this through our support of local JROTC detachments and cadets at seven local high schools in our Chapter catchment area. These high schools are Baker (Army), Choctawhatchee (Air Force), Crestview (Army), Fort Walton Beach (Air Force), Navarre (Navy), Niceville (Air Force), and Walton (Air Force).

The most apparent method of support is the **NWFMOA Scholarship Program**. Established in 1981 when an award of a \$500 savings bond was made to a Crestview JROTC cadet, the scholarship program has grown significantly over the years. Although I do not have complete records of all scholarships awarded, I can say that since 2015 we have awarded 48 scholarships totaling over \$100,000. This does not include the four scholarships we will be awarding this year on May 6, 2022, totaling \$13,500 at our monthly Chapter luncheon. This year we are returning to holding the Scholarship Luncheon at our regular meeting venue at the Fort Walton Yacht Club. Due to restrictions of COVID-19, our 2020 and 2021 scholarship awards programs were held elsewhere.

Another way we support local JROTC units is the **MOAA Medal Program**. This medal was created by the Military Officers Association of America (MOAA)

to recognize leadership and academic achievements of ROTC and JROTC cadets in their junior year of college or high school, respectively. Selectees must be in good academic standing, be of high moral character, demonstrate a high degree of loyalty to the unit, school, and country, and, demonstrate exceptional potential for military leadership. Each year we award the MOAA Medal to a cadet from each of the seven JROTC programs we support. These cadets are selected by each school's Senior JROTC Instructor.

A third method of our support to local JROTC units is by offering an **Educational Support Grant** of up to \$500 per unit fund equipment and/or educational events which are not funded by the schools or the military service of sponsorship.

Ferry Road NE, FWB, FL 32548. **Menu Selections:** **A-** Salad with roasted chicken; or, **B-** Beef Tips with noodles, vegetable medley and side salad. Both meal selections include crackers, beverage, (iced tea, coffee, water), and brownie for dessert. Meals will be plated and delivered to tables by Yacht Club staff. Please make your lunch reservations via the NWFMOA website or through Fred Westfall not later than April 30th. Face covering/mask is optional based on individual preference. Hand sanitizer will be available.

At this luncheon, in addition to presenting scholarships (see awardees below), we will also award the MOAA Medal to seven outstanding JROTC cadets in their junior year of high school, one cadet each from the seven high schools in our area. The presiding officer will be **Fran Hendricks**, Brigadier General, USAF, Ret. We will also recognize the graduating seniors from the seven high schools who have received **military academy appointments** this year, and local JROTC Instructors. Honor Guard for the Presentation of Colors will be JROTC cadets from Choctawhatchee High School.

Scholarship Winners: During the first week of March we received a total of four applications from local JROTC cadets. All of the applicants met the scholarship criteria. Thus, each of them will be awarded at least a \$3,000 scholarship. The Scholarship Fund Board of Directors of **George Colton, Bob Allen, Fred Westfall, Scott Bates, Fran Hendricks, and Dave Parisot** scored each application to be used in determining which cadet will receive the \$4,500 **“Lt Col James ‘Jim’ Heavener, USAF, Ret., and Mrs. Una Heavener Memorial Scholarship”**. Factors scored for each applicant are academic record, education, activities & leadership, honors & awards, community service, work experience, financial need, and recommendations by the JROTC senior officer and others.

On March 30th, each cadet applicant appeared before the Scholarship Board members for a ‘question and answer’ session and scoring. The scores from the written application and the in-person interviews were combined to determine the winner of the \$4,500 scholarship. This winner will be announced at our May 5th Scholarship Luncheon. Recipients of NWFMOA Scholarships are required to enroll in ROTC at their college.

Our four scholarship winners for 2022 are: **Cadet John Harman**, Niceville JROTC; projected to attend Norwich University with a major in Cyber Security; **Cadet Ansleigh Siren**, Niceville JROTC, projected to attend the University of New Orleans with a major in Mechanical Engineering; **Cadet Naomi Barr**, Crestview JROTC, projected to attend the University of West Florida with a major in Pre-Med Biological Sciences, and, **Cadet Quin Gable**, Choctawhatchee JROTC, projected to attend the University of West Florida with a major in Cyber Security.. Each of these cadets will be awarded at least a \$3,000 scholarship with one of the four to be awarded the \$4,500 **Heavener Memorial Scholarship**.

New scholarship designations for this year are the **“Dr. (Lt. Col., USAF, Ret.) Howard and Mrs. Irene Fisher Scholarship”** funded by Howard and Irene; the **“Colonel Robert ‘Bob’ Garcia, USMC, Ret., Memorial Scholarship”**, and, the **“LTC Samuel ‘Sam’ Lombardo, USA, Ret., Memorial Scholarship”**. Each of these three scholarships are for \$3,000. Sam Lombardo passed away on June 11, 2021, just a month short of his 102nd birthday. Bob Garcia died on January 7, 2022 at age 87. Howard and Irene, Sam, and Bob are all long-term donors to the NWFMOA Scholarship Fund and members of the Gold Century Club.

MOAA Medal Winners: In past years the MOAA Medals have been presented by a Chapter member at each school’s JROTC Awards program. In 2020, due to COVID-19 restrictions, we mailed the MOAA Medals and certificates to the schools for presentation by the JROTC Instructors. In 2021, as most schools still had restrictions on non-school presenters at their JROTC Awards programs, we decided to bring the winning cadets to our Scholarship Luncheon as our guests for the presentations. I received many very positive comments on this from our members present, so we are doing it again this year. This year’s MOAA Medal winners and their units are: **Cadet MSG James Johnson** (Crestview JROTC); **Cadet Carter Van Ohnen** (Fort Walton Beach JROTC); **Cadet Ensign Coltyn Young** (Navarre JROTC); and, **Cadet Perla Gonzalez** (Walton JROTC). MOAA Medalists for Niceville, Baker, and Choctawhatchee JROTC units have not yet been selected as of this writing.

At this year’s Scholarship Luncheon we will also recognize local high school seniors who have received appointments to one of our military academies. Known appointees as of this writing are **Leanne Gujski, Massimo Grisotto, and Page Dolloff**, all of Niceville High School and all to the USAF Academy; and Navarre JROTC **Cadet Gavin Unterreiner**, to the USAF Academy. I do not yet have all the names of this year’s military academy appointees from our seven

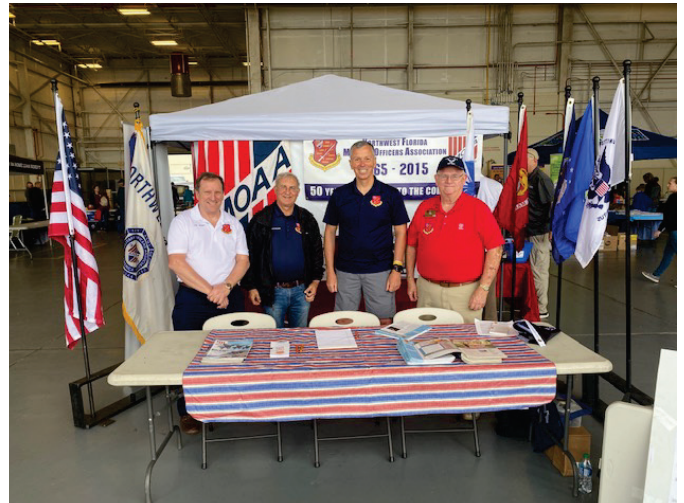

Is there a more grateful way to make this Mother's Day more meaningful? For most of us retirees our mothers have already passed away. Mary and I will light a candle after Sunday worship in their honor. We will cook their favorite meal, write special remembrances in our gratitude book, and yes we will even take an afternoon nap just like they did.

Since both their graves are in New York, we will call our siblings and children to retell some stories. If you can visit her grave with your children, talk to her, pray, put a card, flower and a coin at her headstone.

To the children and grandchildren I say plan a few days and treat her like a queen. Go through photo albums, take her to her favorite places. Maybe you have a box with some letters, items she made, pictures etc. We transcribed old 8mm to CD so she could see family trips from the 1960's. We still keep a picture of our mothers on our hutch.

My mother was strong; she raised five children on her own. She was very spiritual and made sure we met every night at 7 o'clock for family devotions.

She prayed for neighbors who were going through a difficult time and put her prayers into action by cooking a meal for them. She was hard-working, supportive and very generous.

At critical junctures in my life she offered good insight into parenting, ministry and retirement. She had the 'lived experience' and knew her children better than any self-help author. Her rare gift was the ability to listen without interrupting. Her advise was always backed up with "I'm here if you need me."

Yes I think of mom when her tv show comes on, or a food plate, or quip. The grief is gone because her love was constant and strong. She was unpretentious and humble, volunteered behind the scenes and never wanted an award.

When she faced her own difficulties she was stoic. She paved a new road from her spiritual and prayerful attitudes through health and financial issues. Today we see ourselves in our mother's words and behaviors, and play it forward to the next generation. Thanks mom for a life well lived.
