### Air Force Turns 69

1949 – Present: Air Force Historic Events

The official date of the founding of the US Air Force is 18 September 1947. It was a momentous event that over six decades later has demonstrated the achievement of an Air Force second-to-none, yet the Air Force's history and heritage goes back a lot further.

From the time that the US military purchased its first aircraft in 1909 up to 1947, the US Air Force did not exist as a separate and independent military service organization. It went through a series of designations: Aeronautical Section, Signal Corps (1909); Aviation Section, Signal Corps (1914); United States Army Air Service (1918); United States Army Air Corps (1926), United States Army Air Forces (1941).

WWII illustrated the value of airpower, and the need to change the basic organization of the US Military Forces. The result was the creation of a single Department of Defense with a strong Joint Chiefs of Staff with Army, Navy, and Air Force chiefs. In 1947 President Truman signed the National Security Act which established this new defense organization, and along with it the creation of the US Air Force as an independent service, equal to the US Army and US Navy. The official birthday of the US Air Force is 18 September 1947.

Through the years history has shown the wisdom and foresight of the creation of a separate Air Force. The US Air Force emerged quickly from its cradle and began to create its own history and heritage.

1949: The flight of the "Lucky Lady II" demonstrated the Air Force's capability to fly, non-stop round the world, showing it could take off from the U.S. and drop bombs anywhere in the world.



1950-1953: USAF engaged in the first completely jet aerial combat During the Korean War. The F-86 Saberjet scored impressive aerial victories against the enemy MiG-15.

### **Building Community in the Local Chapter**

For the past two years, the Greater Birmingham (Ala.) Chapter has sponsored biannual ladies' luncheons for spouses, surviving spouses, and female military officers to socialize, disseminate information, and increase membership and attendance at chapter meetings. In addition to sending invitations to women already associated with the chapter, invites are sent to members of the Birmingham Officers Wives Club, an independent organization, wives of MOAA Alabama Council of Chapters officers, and surviving spouse liaisons in Alabama.

During the luncheon, attendees receive updates on legislative issues along with information about benefits such as discounts for cell phone service, restaurants, and stores. Many have expressed great appreciation for the information and materials they have received. In addition, an Alabama's Survivor Outreach Services coordinator always attends and discusses how she can assist, especially when a death occurs, and I provide MOAA updates, such as a preview of Storming the Hill; review the benefits of both local and national MOAA membership; and give an overview of MOAA's publications.

At the last luncheon, a representative from the Jefferson County Veterans Service Office for the Department of Alabama spoke on VA benefits and eligibility.

As a result of these luncheons, several attendees have encouraged their husbands to join the local chapter, and some also have started to attend chapter meetings. Additionally, as luncheon attendees get to know each other, they want to attend chapter meetings to see friends, and they bring their spouses. Plus, surviving spouses seem more comfortable attending meetings, and some now carpool together.

The engagement provided by the ladies' luncheons is helping to solve the membership and attendance challenge many MOAA chapters face.

### NAVY TURNS 240

The U.S. Navy traces its roots back to the privateers that were employed to attack British commerce in the early days of the revolution. On October 13, 1775, the Continental Congress established a naval force, hoping that a small fleet would be able to offset the uncontested exercise of British sea power.

The early Continental navy was not expected to take on the British navy for control of the seas. This small naval force was designed to work with privateers to wage tactical raids against the transports that supplied British forces in North America. To accomplish this mission the Continental Congress purchased, converted, and constructed a fleet of small ships-frigates, brigs, sloops, and schooners. These navy ships sailed independently or in pairs hunting British commerce ships and transports like prey, avoiding whenever possible fights with Royal Navy men-of-war.

The Continental navy faced several obstacles both during and after the revolution – mostly political and economic. Two years after the end of the war, the money-poor Congress sold off the last ship of the Continental navy, the frigate Alliance.



In the 1790's Europe began to relax many mercantile commercial restrictions and the U.S. trade and the shipping industry expanded accordingly. However, as the number of U.S. ships increased so did the possibility increased attacks by the European powers and pirates. In March 1794 Congress responded by calling for the construction of a half-dozen frigates. And, once again, the United States had a navy.

Although the Continental navy was later dismantled, October 13, 1775 remains the U.S. Navy's official birthday.

From these humble beginnings, the world's most powerful naval force was born. With thousands of ships and aircraft serving worldwide, the U.S. Navy is a force to be reckoned with. To learn more about the early years of the U.S. Navy, visit the U.S. Naval Historical Center website.



1954: The first B-52 Stratofortress came into the USAF Inventory and has served in every conflict since its appearance.

1960s: The development and deployment of Intercontinental Ballistic Missiles (ICBMs) as a major component of the aerial defense capability of the United States.

1964-1973: War in Vietnam

1970s: The development of laser-guided bombs and TV-guided air to ground missiles. Air mobility took a major step forward with the introduction of the C-5 Galaxy in the Air Force Inventory. Other aircraft systems introduced in this decade were the F-15, A-10, AWACS, and F-16.

1980s: Stealth Technology was revealed advent of the F-117; strategic bomber capability was increased with the deployment of the B-1.

1990s: USAF played a major role in the swift defeat of the Iraqi military forces in the first Persian Gulf War: The Air Force underwent a major reorganization with the formation of Air Combat Command, Air Mobility Command, and Air Force Materiel Command. The USAF supported the war in the Balkans, and the US intervention Operation Uphold Democracy in Haiti.

2000 -- Present: The Expeditionary Air Force concept was a major transition in how the Air Force employed forces. The Global War on Terrorism brought the USAF into Operation ENDURING FREEDOM and Operation IRAQI FREEDOM.

### Scholarship Fund

At recent chapter meetings I have been asked some questions in regard to any relationship between our NWFMOA Scholarship program and that of the national MOAA. Do we receive any scholarship money from MOAA? If I donate \$100 or more to the MOAA scholarship program, why am I not listed in the **Defender** and on our **www.NWFMOA.org** website? Are our JROTC cadets at the Okaloosa County high schools eligible for the MOAA scholarships? Do we send any of our donations to our NWFMOA Scholarship program to MOAA?

In a nutshell, the two scholarship programs (NWFMOA and MOAA) are separate and distinct from each other. All donations to and funds raised by our NWFMOA Scholarship Fund are used to support our local program of offering five scholarships annually (totaling \$9,000) to JROTC cadets of our five local high schools. [Please see the **Scholarship Donation Form** in the **Defender** to donate.] We do not send any funds to the national MOAA program, nor do we receive any scholarship funds from MOAA. Also, I am not notified when a member of NWFMOA makes a donation to the MOAA program. Those donations are listed periodically in MOAA's <u>Military Officer</u> magazine.

Yes, our local JROTC cadets are eligible for the national MOAA scholarships if they meet MOAA's criteria. They must submit a separate application (available on the MOAA website) and follow MOAA's rules for information and documentation. The criteria and application for our NWFMOA scholarships can be found on the Scholarship pages at www.NWFMOA.org.

Both scholarship programs are very worthy and provide financial assistance to JROTC cadets as they attend college. I hope the above information clarifies the two scholarship programs.


