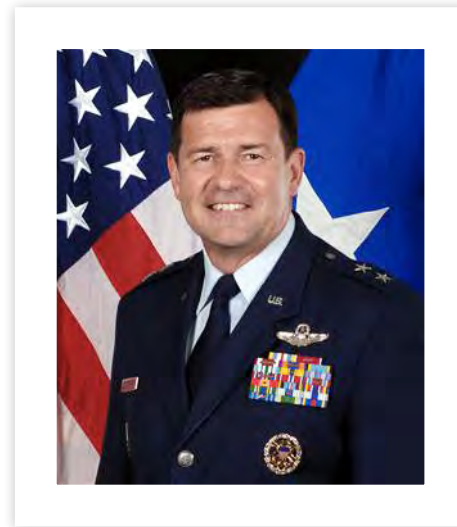
Welcome Back!

At our March 5, 2020, meeting of the Northwest Florida Military Officers Association, we were pleased to host Colonel (Dr.) Matthew Hanson as our guest speaker. Colonel (Dr.) Matt Hanson is the Commander, 96th Medical Group, 96th Test Wing, Eglin Air Force Base, Florida.

Dr. Hanson gave our audience an overview of the mission of the Eglin hospital, and explained the objectives of the hospital's three mission areas-- the challenges of managing healthcare for active duty and retired members throughout the Panhandle, and future issues and challenges facing the hospital. Dr. Hanson concluded by saying Eglin is facing unprecedented growth, but the hospital was not going to reduce privileges to retired members. While

and Management at California Lutheran University. He retired from the US Air Force in 2011 as a Major General. He has extensive experience in a wide range of disciplines including Defense and Aerospace, Technology Development, Government Acquisitions and Requirements, Foreign Military Sales and Leadership Coaching. SG Strategic Solutions assists defense industry and partner air forces in Strategic Planning, Capabilities Based Risk Assessment, Force Structure Analysis, Acquisition Program Review and Analysis, Foreign Military Sales, and C4ISR programs. As a Leadership coach he instructs classes ranging from first time managers to senior VP and CEOs on Leadership techniques to improve company bottom line, retention, communication skills, and strategic planning. He has taught Leadership in uniform and in civilian life for over 25 years.

Recently, he was Vice President, International Business Development at Raytheon Corp, prior to that he was Director of Air Force and FAA programs at Engility Corporation. He retired from the USAF in December, 2011 with over 33 years of distinguished service in several capacities overseas and in the United States. His last position was Assistant Deputy Under Secretary of the Air Force for International Affairs (SAF/IA), responsible for formulating and executing US Air Force Policy, Strategy and Programs for Building Partnerships around the globe, and integrating Air Force policy with international partner goals and expectations totaling over \$40 billion total program value.

From 2007 to 2010 Maj Gen Snodgrass served as Chief of Staff, US Africa Command. In that position, he was responsible for the construction of America's newest Unified Geographic Command. As Chief of Staff, he directed the Command in the full range of activities with 53 African nations including military to military training, education, exercises, community relations, Foreign Military Sales totaling over \$3.5 billion, on-going military operations in support of the war against extremism, and overseeing planning and execution of an annual budget for the command in excess of \$500M per year. From 2005 to 2007 Maj Gen Snodgrass was Director of Plans, Programs and Analysis for US Air Forces Europe. He has commanded at the squadron, group and wing levels and served at every staff echelon in operations, requirements, acquisitions and international affairs while in uniform. He has over 3500 flight hours in various aircraft including the F-16, F-15, F-4, C-130 and

“FOLDED ON THE FOURTH OF JULY”

At a recent flag folding ceremony in Shalimar last month many veterans and widows inquired about the meaning of each fold as some had never heard it before. The following is my rewrite and used for many services I conducted in both military and civilian events.

Introduction

“Our flag represents the democratic and religious principles on which our country was founded. Our flag inspires passion and recalls history. We wear and fly it at work, home, abroad and in our barracks. Every evening at the ceremony of retreat our flag is lowered, folded and kept under watch throughout the night as a tribute to our nation’s honored dead. The next morning at reveille, it is run aloft as a symbol of our belief in the new life and the resurrection.

The blue color represents authority and justice. The stars are in the heavens and the white lines are the pure light emanating from there. The red color is the blood shed for our nation’s ideals by our military men and women.

(The honor guard is unraveling it while the above introduction is read.)

1-The first fold represents Almighty God, who creates, guides, heals and sustains us with truth and grace. The first fold is the integral cornerstone for all others.

2- The second fold embodies our solid belief in both our personal and military family- known to those with the lived experience of service to country.

3- The third fold denotes the 3 committed roles of every Airmen- “Wingman, Warrior and Leader.” The mission of every airmen and his or her family is to be freedom’s light to those in a dark world.

4- The fourth fold constitutes our mental, physical, emotional and spiritual dimensions, that when united under the Laws of God and country, yield victory over self and the enemy.

5 The fifth fold is our unswerving allegiance to the sacred oaths and traditions of honor that one will not lie, cheat or steal, or allow others too, both on and off duty, so we can fly, fight and win with integrity.
