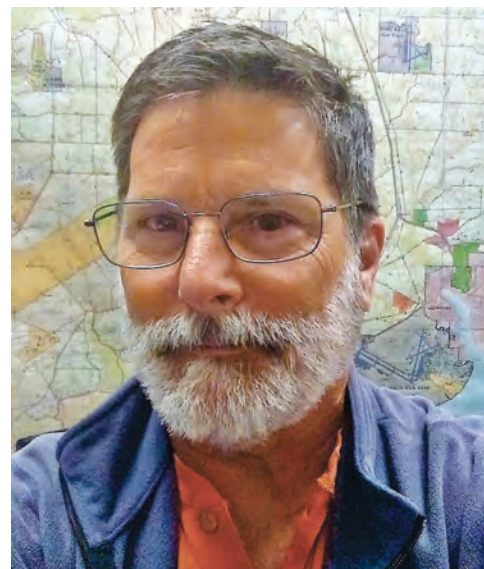

The speaker for our 6 June meeting will be Joe Meyer, from the Cultural Resources Branch at Eglin.

Joe Meyer is native of Louisiana and resident of Navarre Florida with a BA degree in Anthropology from Louisiana State University (1986) and a MA degree in Interdisciplinary Humanities from University of West Florida (1999). For the past 15 years, Joe has worked as a Research Associate III, with the Center for Environmental Management Military Lands (CEMML), Colorado State University. With over 30 years of experience in cultural resource management across the Southeastern

US, much of which is on Eglin AFB, Joe provides guidance on Federal Laws and Regulations such as the National Historic Preservation Act and the Archaeological Resource Protection Act. In his off-time he enjoys nature photography, outdoor activities, and spending time with his family.

Located in the panhandle of Northwest Florida, Eglin Air Force Base is the Air Force's largest installation. EAFB's host unit is the Air Armament Center, (AAC) whose responsibilities include the development, acquisition,

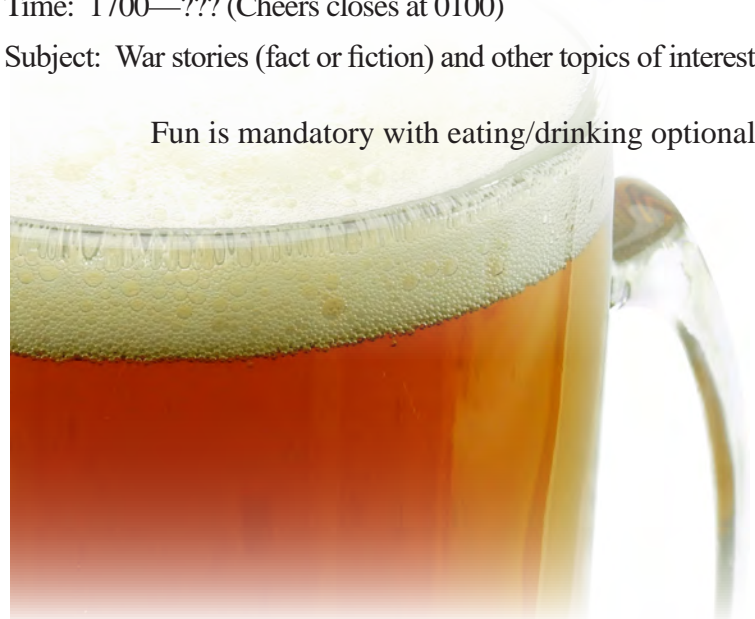

Easter week I had the unique opportunity to participate in the first-ever Gold Star and Surviving Family Member Summit at Bob Hope Village, hosted by AFPC.

It was a true honor for me to be there. The three groups were: 1) parents of military members killed in action; 2) children who attended the conference who lost a parent, and 3) the largest group were the spouses, of whom many were from Air Force Special Operations Command.

The organizer asked for the opening prayer and then have each person stand give their name, the name of their relative, what they're mission was, and how they died. After each person spoke I rang the church bell. Thirty voices brought many to a new level of understanding and to a deeper level of empathy. Later in the afternoon these three groups met separately and shared their observations, recommendations and their tears. We were all humbled by their strength. It was a very healing experience as family members shared from their unique perspective their challenges their hopes and their anchors.

We have all worn the uniform and have lost peers on the battlefield. There is no easy answer. We all grieve differently and we all have our own unique Island that we go to, to pray, meditate or share our world of pain. It is one of the reasons I am in MOAA--I can share my experiences and gain comfort and insight, and reciprocate to those who have suffered.

This was my prayer:

“Let us pause to remember those currently serving and their family members around the globe...

Hear the silent prayers of each person oh God. We honor the courage of those who came today to this conference for they were the ones who possessed and passed on the courage to those who lived out their final unselfish act of warrior heroism.

You know and care uniquely for each of us oh Lord, and we acknowledge how you nurtured each of these: the love and fidelity of the spouses, the filial piety of their children, the love of each parent for their children, the special bond of their peers and the gift of your living faith.

testing, deployment, and sustainment of all air-delivered conventional weapons. The size of Eglin's workforce is approximately 22,000 military and civilians within the AAC and its 46 associate units.

Eglin is roughly three-quarters the size of the state of Rhode Island with more than 464,000 acres of long-leaf pine forest, unique pristine ecological areas, sensitive coastal shorelines, and wetlands. Weapons testing ranges cover a large portion of the Eglin reservation. These land features are attractive to military planners and trainers because the features present an optimum landscape for a variety of training scenarios.

In addition to the AAC's diverse mission, Eglin has seen an increase in requests to conduct ground personnel training operations on its land over the years. A robust cultural resources program is required to preserve and protect these resources from potentially adverse effects of these actions.

Eglin AFB hosts an array of cultural resources that range from prehistoric occupational sites to pioneer homesteads and ruined missile launch sites. In fact, Eglin's site inventory is the largest collection of cultural resources located on an Air Force installation in the southeastern United States.

The Cultural Resources Management Branch at EAFB is a small but extremely dedicated team of civil service personnel led by the Base Historic Preservation Officer (BHPO). This team also includes the contracted services of information technology experts and archaeologists. Everyone with access to EAFB, from local campers to the Eglin workforce, is relied upon to help protect these resources. Counsel from the State Historic Preservation Officer (SHPO) and the Advisory Council on Historic Preservation (ACHP) is utilized in combination with modern technology to carry out this responsibility.

During Fiscal Years 2005 and 2006, Eglin's leadership saw the beginnings of change to the base's landscape through the Base Realignment and Closure (BRAC) decisions made by Congress. These decisions included the consolidation of all the initial Joint Strike Fighter

After the launch of the new VA Community Care Program, or VCCP, veterans can expect:

- “To continue to have access to community care under current programs and then transition to the new program when regulations are final and published.
- To follow an improved process to receive community care under the new program, with better access to community providers and improvements to customer service, such as more streamlined eligibility requirements.
- A new benefit that provides eligible Veterans with access to urgent, non-emergency care for non-life-threatening conditions in VA’s network of community providers
- Improved care coordination as VA transitions to a single information technology system that better links together VA and community providers.
- Your provider to receive timely payments for bills as VA transitions to better claims processing systems.”
- That’s the official word from VA. Simply put, once the VCCP is fully rolled out, veterans can expect to have access to urgent care; see eligibility for community care expanded; be able to schedule their own or have VA schedule their community care appointments; and experience improved communications.

On May 6, VA headquarters provided MOAA and a few other veterans groups some training on VCCP so we can start sharing information with veterans.

First and foremost, veterans, including myself who have been using VA regularly must be prepared for a few bumps during implementation. Though VA is expecting most of the health system changes will be seamless, and

NWFMOA Awarded MOAA Community Grant

The Northwest Florida Military Officers Association (NWFMOA), Florida Chapter 19, was awarded a community grant of \$3,750 on April 18, 2019 by the Military Officers Association of America. A Chapter member has pledged a 50% match to the MOAA grant which will bring the total to \$5,625. These grant funds will be used to purchase furniture to outfit rooms for homeless Veterans as part of the expansion of housing at One Hopeful Place in Fort Walton Beach. When the furniture is received, volunteer members of NWFMOA will meet at One Hopeful Place to assemble the furniture and place it in the new living facilities.

This is the second consecutive year that NWFMOA has received a MOAA Community Grant. Last year’s award of \$3,000 was used to purchase items to support local homeless Veterans in conjunction with the 10th Annual Homeless Veterans Stand Down of Okaloosa County.

training sites to Eglin. In addition, the U.S. Army's 7th Special Forces Group was relocated from Fort Bragg, N.C., to EAFB. The Department of Defense (DoD) also started its Military Family Housing

The historical and cultural resources managed by Eglin include:

- 2,068 archaeological sites (three National Register listed sites, 450 eligible/potentially eligible)
- 144 total historic buildings — 46 National Register listed buildings, 98 eligible

In the wake of Hurricanes Ivan and Dennis, Eglin cultural resource managers reviewed more than 1,000 work order documents to ensure that Eglin hurricane clean-up/repair operations didn't adversely affect or cause further damage to historic properties. Eglin's cultural resources managers have worked extremely hard to protect and recover artifacts from these sites. These sites are regarded as some of the best interpretations of the pre-Eglin cultures. Despite these challenges, Eglin's cultural resources managers have succeeded in balancing the complex needs of EAFB's military mission while protecting and preserving the installation's valuable cultural resources.
